This may include, but is not limited to, the following: an Animal Waste Management Plan (AWMP), a Nutrient Management Plan (NMP), a Carcass Disposal Plan (CDP), or any other applicable changes that accounts for the proposed head increase.
- 6. If increasing the size of your operation will include construction activities (dirt work) and the cumulative soil disturbance is one acre or more, you are required to submit to ODAFF a Notice-of-Intent (NOI) application for storm water discharges associated with construction activities.
