### IMPORTANT:

- **Permit is only valid for one year from date of issuance.** Deficiencies or the inability to read any required information will result in rejection of an application.
- Supporting documentation, including proof of insurance, rating, and medical must be included with this permit application.
- **Take** is the hunting and killing of certain wildlife. The law only allows the hunting of coyotes, coyote/dog crosses, and feral hogs; therefore, be aware of those species when requesting authorization to take. The name of the species and the number of animals must be clearly identified. *The number requested to take/hunt is the maximum number that may be taken in any single calendar year.*
- Copies of the signed written permission of the landowner must be submitted, along with a copy in your possession while conducting aerial activities.
- Failure to provide accurate and timely reports can result in the revocation of the permit and other penalties.
- Permittee will be required to file within (30) days of each calendar quarter, a report of flight dates, participates, animals managed and types.
