- Authorization letter or contract stating the partnership between the institution of higher education and the subcontractor.
- Proof of ownership for the cultivation site where the industrial hemp is to be grown. Proof of ownership may be a copy of a deed, affidavit, or other documents that sufficiently prove ownership.
- Annotated map or aerial photograph to define boundaries of the cultivation site with a variety description of the industrial hemp corresponding to each growing area.



Legal Statement

I, (*print name*) _____, the owner or person with legal control of and authority to bind, the herein named applicant, have read and understand all of the conditions and obligations stated herein. I understand and agree, as required by Oklahoma Industrial Hemp Agricultural Pilot Program:

- all varieties of industrial hemp seed shall be certified by the Department.
- if the industrial hemp grown exceeds 0.3% delta-9 tetrahydrocannabinol concentration by dry weight, the crop will be destroyed.
- any information provided by licensee is subject to public disclosure under the Open Records Act.
- any information provided by the institution of higher education or subcontractors may be released by the Department to law enforcement agencies without notice to the institution of higher education or subcontractors.
- the institution of licensee shall fully cooperate with the Department, grant the Department physical access to any part of the cultivation site and allow inspection and sampling that the Department deems necessary.
- Licensees are responsible for an hourly inspection rate of \$35.00 per hour per inspector for actual time devoted to the inspection of a contiguous field or building and are to pay within 30 days of receiving an invoice from the Department.
- Licensees are responsible for the laboratory analysis costs of sample(s) and are to pay within 30 days of receiving an invoice from the Department.
- the licensee shall submit all required reports by the dates specified by the Department.
- the licensee shall file a harvest report for each license on a form provided by the Department.
